## 1. Présentation / Introduction

Le Schéma pluriannuel de mise en accessibilité pour applications Mobile 2023-2026 (ci-après « le Schéma ») a été élaboré conformément au point III de l'article 47 de la Loi n° 2005-102 du 11 février 2005 pour l'égalité des droits et des chances, la participation et la citoyenneté des personnes handicapées. Ce Schéma vise à garantir l'amélioration continue des applications Mobile de *Sony corporation* (ci-après « Sony ») proposés en France et leur accessibilité à tous, y compris aux personnes handicapées et aux personnes âgées.

The Multiannual Accessibility Plan for Mobile Applications 2023-2026 (hereinafter – Plan) has been established in accordance with III of Article 47 of *Law No. 2005-102 of 11 February 2005 for equal rights and opportunities, participation and citizenship of people with disabilities*. This Plan seeks to ensure a gradual improvement of *Sony corporation* (hereinafter – Sony) mobile applications offered in France and their accessibility to all, including members of the disabled community and the elderly.

## 2. Applications Mobile Concernées / Applicable Mobile Applications

Ce Schéma s'applique à l'application mobile Cinematography Pro.

This Plan applies to Cinematography Pro mobile application.

## 3. Politique d'accessibilité de Sony / Sony Accessibility Policy

Sony s'engage à concevoir et à développer des applications Mobile accessibles sur la base de l'EN 301 549 V3.2.1 et s'efforce d'améliorer et de garantir l'accessibilité.

Sony is committed to design and develop accessible mobile applications based on EN 301 549 V3.2.1 (2021-03) and is striving to improve and maintain the accessibility.

## 4. Ressources d'accessibilité / Accessibility Resources

Sony dispose d'une équipe dédiée qui promeut en permanence l'accessibilité des applications Mobile, et d'une équipe utilisant les outils liés à l'accessibilité.

Sony has a team that will continually promote accessibility of mobile applications, and a team uses accessibility related tools.

## 5. Sensibilisation et formations / Awareness and Trainings

Sony réalisera une gamme de formations sur l'accessibilité ciblant les nouveaux employés et les différents rôles dans l'organisation; de l'introduction à l'accessibilité jusqu'à des formations plus ciblées pour les ingénieurs et les développeurs.

De plus, Sony organisera des formations régulières sur l'accessibilité pour les agents du service client qui, entre autres, décrivent ce qu'est l'accessibilité, quels sont les bénéficiaires de l'accessibilité, les exigences légales en matière d'accessibilité en France, la manière de répondre aux demandes et questions relatives à l'accessibilité des applications Mobile.

Sony will conduct a range of accessibility trainings targeting new employees and different roles in the organization; from the introduction to accessibility to more targeted trainings for engineers and developers.

Moreover, Sony will conduct regular training on accessibility for customer service agents which, among others, describe what accessibility is, who requires accessibility, legal requirements on accessibility in France, how to address requests and questions on mobile applications' accessibility.

## 6. Recrutement / Recruitment

## 8. Répondre aux exigences d'accessibilité / Addressing Accessibility Requirements

Sony répond aux exigences d'accessibilité, pas seulement en France, mais sur le plan organisationnel. Le siège de Sony a émis une norme technique et un manuel technique auxquels l'ensemble du groupe Sony, incluant *Sony corporation*, s'efforcera de respecter.

Le siège de Sony, en coopération avec les équipes régionales de l'UE, communiquera les exigences d'accessibilité françaises aux filiales du groupe Sony concernées, et s'assurera que l'ensemble des exigences pour les applications Mobile soient respectées dans le délai fixé.

A l'avenir, chaque application Mobile sera soumise à un contrôle lors du premier lancement ou d'une mise à jour majeure dans le but de se conformer à l'EN 301 549. Ces contrôles garantiront l'élaboration et la publication de la déclaration d'accessibilité conformément à la loi. Les contrôles, y compris les évaluations de conformité, seront réalisés par des experts internes expérimentés en accessibilité des applications Mobile.

Sony is addressing accessibility requirements not just in France but from an organizational perspective. Sony headquarters has issued a technical standard and technical manual which the whole Sony Group, including *Sony Corporation*, will strive to comply.

Sony headquarters in cooperation with EU regional team will communicate the French accessibility requirements to the relevant Sony Group companies and will ensure that all the requirements for mobile applications are met before the deadline.

Moving forward, every mobile application will be subject to a control during the initial launch or a major update aiming to comply with EN 301 549. Such controls will ensure a preparation and publication of the accessibility declaration in accordance with the terms of the law. The control, including conformity assessment, will be carried out by internal experts competent in mobile application accessibility.
