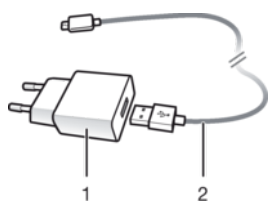

Introduction

Charging made easy

The Quick Charger **UCH12W** reduces the charging time for Xperia™ devices that support the Qualcomm® Quick Charge™ 3.0 standard and MediaTek Pump Express +™ 2.0. Using the Quick Charger, you can quickly charge an Xperia™ smartphone or an Xperia™ tablet.

- ! When charging a device with the Quick Charger **UCH12W**, always use the **UCB20 USB Type-C™** cable or the **UCB11** Micro USB cable that was included with the charger at purchase.

- 2 **UCB20 USB Type-C™** cable or **UCB11** Micro USB cable

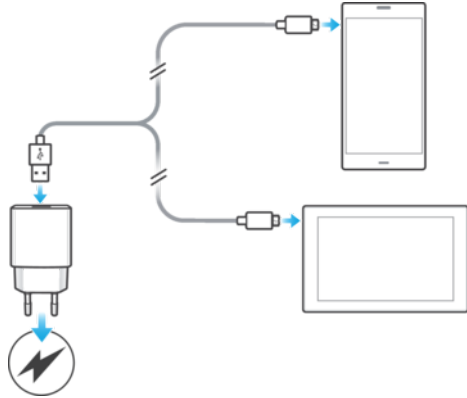

Using the Quick Charger

Charging

To charge your device using the Quick Charger



- 1 Plug the **USB Type-C™** or the Micro USB connector into the **USB Type-C™** or the Micro USB port of your device.
 - 2 Plug the larger USB connector at the other end of the cable into the charger.
 - 3 Plug the charger into a power outlet. Your device battery then starts to charge.
 - 4 When your device is fully charged, unplug the charger from the power outlet and disconnect the cable from your device by pulling it straight outwards. Make sure not to bend the connector.
- 💡 If no power outlet is available, you can also use the USB cable to charge your device from a computer. Simply plug the larger USB connector into a computer USB port instead of the charger. Note that this method will charge your device battery more slowly than when using outlet power.
